He also has considerable experience in managing tax disputes involving the IRS and Washington Department of Revenue along with contract claims related to tax issues in business transactions.

He has also advised a major utility on Washington state tax issues involving wind and hydro projects. He is a presenter on tax and legal issues related to alternative energy, particularly on changes of law and policy under the 2022 Inflation Reduction Act and under Washington law. Chris also
